I agree that if Snoqualmie Valley School District determines, in its sole discretion, that I have provided false or incomplete information in response to the above questions, or the District decides, with or without cause, not to approve or retain me as a volunteer for whatever reason, Snoqualmie Valley School District may, without notice or other process, reject my application to serve as a volunteer, or revoke my privilege to serve as a volunteer.
