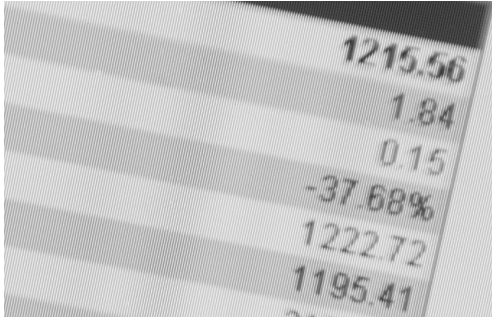

- **School Employees:** Simply complete the **School Payroll Authorization** on the back of this flier, sign it, and give the form to your payroll department. If you would like your entire paycheck deposited to your credit union account, ask your payroll office about direct deposit.
- **Non-School Employees:** Please contact your payroll office to set up automatic deposits of either a portion of your paycheck via payroll deduction or your entire paycheck via direct deposit.

** For amounts over that, they'll continue to earn the credit union's regular competitive rates. The benefit will be limited to one savings and one checking account receiving e-Statements and direct deposit/payroll deduction per primary account holder. For members with multiple savings and checking accounts, the rate will be applied to the accounts that have been open the longest. Youth accounts qualify without automated deposits.
